**JOB TITLE: IRRIGATOR (3 POSITIONS)**

#### **SUMMARY:**

An Irrigator will be responsible for water control in the farm ditches and fields. Irrigator will be required to be at the job site at all times until shift changes or jobs are completed. This position requires working outside in extreme temperatures.

#### **DUTIES:**

- Stay on the job site when irrigation water is running.
- Monitor chemical water runs, fertilizers, herbicides, etc.
- Must have knowledge of and experience in cement work.
- Shovel for up to 8 hours a day.
- Handle 2 to 3 heads of water at a time.
- Must be aware of field conditions due to aerial or ground applications, re-entry period and so forth.
- Must be able to operate backhoe and tractors.
- At times, will enter underground pipe lines for repairs.
- Responsible for tools and equipment issued out.
- Closely monitor water, especially during high peak consumptions and ensuring no excess tail water or 'ponding up'.
- Must be able to cross train under different supervisors and perform other job duties as needed.

**REQUIREMENTS:**

Applicant must have a High School Diploma or GED, current valid driver's license and/or at least 5 years of experience in irrigation. Must be able to follow Supervisor's instructions, write legibly, and communicate with ditch riders. Must also have reliable transportation and a telephone.
