GENERAL SUMMARY:

Located on the banks of the Colorado River in Parker, Arizona, the Colorado River Indian Tribes' Ahakhav Tribal Preserve works to restore and protect native plants, wildlife and resources. The Ahakhav Native Plants Nursery provides all plants used in the Preserve's restoration projects. DUTIES:

The Nursery Director will be in charge of all greenhouse/nursery activities that support the Preserve's re-vegetation projects. The Nursery Director will oversee and participate in the germination process, seeding care, pole cutting and greenhouse/nursery maintenance of desert, mesquite and riparian woodlands plants. The Director will also assist in planning and preparing vegetation for research plots. The Director may be asked to seek additional means of financial support for projects, including grants and income. The Nursery Director will work mainly outdoors and applicants are encouraged to have a familiarity with the Arizona climate.

EDUCATION REQUIREMENTS, SKILLS & ABILITIES:

A Bachelor's degree in horticulture of five plus years' experience working in agriculture or restoration, especially woody species and desert plants. Must have experience managing a work crew. Excellent written and oral communication skills, attention to detail, a self-motivator. Must be able to work outside, often doing repetitive physical tasks and lifting heavy objects in the desert heat. Ability to speak Spanish is a plus. GIS and web design skills also a plus. Must possess a valid Driver's License.
