DUTIES AND FUNCTIONS:

- Must have a minimum of one year Redi-Mix Driver experience.
- May also be required to make aggregate deliveries utilizing Transfer and Ten Wheel Dump Trucks.
- Must possess a current Class "A" CDL and medical Card and/or Class "B" CDL with Tanker Endorsement.
- Will be responsible for truck appearance. Acid washing, removing dries concrete from inside drum of Redo-Mix Truck and general cleanliness will be required.
- Must be physically able to assist in maintenance on all vehicles, equipment and plants when required.
- Due to the high frequency of stress associated with redi-mix and asphalt deliveries, teamwork is essential and required. Must be able to get along with co-workers and follow instructions from dispatcher.
- Starting and ending time may vary on an everyday basis depending on contractors and jobs. It is mandatory that drivers show up at their assigned starting times. May be required to work overtime, Saturday and occasionally Sundays.
- Truck Drivers will be required to dress in the appropriate manner. Clothing will be neat and clean. Steel toed boots will be required before employment.



- It is imperative drivers handle themselves in a professional and courteous manner when dealing with customers.
- Will be required to drive personal vehicle to both Parker and Ehrenberg Plants.
- Will be drug tested prior to employment and randomly that after.
