Fee Schedule

Item	Description	Fee
Annual	All persons engaged in business on the reservation for a period exceeding three (3) months shall have an annual business license. Tribal taxes may apply.	\$125.00
Seasonal	All persons engaged in business on the reservation for a period of more than four (4) days but less than three (3) months shall have a seasonal business license. Tribal taxes may apply.	\$75.00
Temporary	All persons engaged in business on the reservation for a period of four (4) days or less shall have a temporary business license. Tribal taxes may apply.	\$50.00
Peddler - Food*	All persons engaged in business on the reservation as a "peddler" shall have a peddler license. A peddler possessing a valid peddler license shall be exempt from paying applicable tribal taxes.	\$150.00
Peddler - Non-Food*	All persons engaged in business on the reservation as a "peddler" shall have a peddler license. A peddler possessing a valid peddler license shall be exempt from paying applicable tribal taxes.	\$100.00
Business Name/Owner Change	Must cancel existing license if owner and/or EIN or SSN changes.. Requires new application and new business license processing.	\$100.00
Add/Remove Owner/Partner	Requires written authorization to add/remove any individual's name. Requires new application be filed on record.	\$100.00
Expedited Processing	Business License processed within 1-2 business days and sent via Priority Mail Express	\$30.00
Replacement Business License	Replacement of Business License.	\$5.00
Copies	Price per page. Any copies including copies of prior applications on file. Does not apply to Business License copies.	\$2.00

*"Peddler" means any person with no fixed place of business who goes from any place to place within the exterior boundaries of the Colorado River Indian Tribes' Reservation for the purpose of offering for sale, displaying or exposing for sale, selling or attempting to sell, and delivering immediately upon sale, or attempting to obtain orders for, the goods, wares, products, merchandise, food, or other property that the person is carrying or otherwise transporting. Peddler shall include a transient merchant, meaning any person with no fixed place of business who temporarily engages in business out of a vehicle, cart, stand, wagon, trailer, boxcar, tent, other portable shelter, empty store front, or from one's person, within the exterior boundaries of the Colorado River Indian Tribes' Reservation for the purpose of exposing or displaying for sale, selling or attempting to sell, and delivering goods, wares, products, merchandise, food, or other property, and who does not remain or intend to remain in any one location or within 100 yards of that location for more than four (4) consecutive days.
